Dear Ms. Herbrick:

I am pleased to report Jersey Village High School Gold Duster Parent Club meets the requirements for exemption from the Texas limited sales, excise, and use tax as a 501(c)(3) organization effective February 8, 1999.

It may issue an exemption certificate instead of paying the limited sales, excise, and use tax on taxable items that relate to the purpose of the exempt organization and are not used for the personal benefit of an individual.

The enclosed certificate does not require a number to be valid, and it may be reproduced locally in any quantity.

If your organization makes any sales of taxable items or services, please contact our Tax Assistance Section at 1-800-252-5555 to determine if a sales tax permit is needed. The direct number is 512/463-4600.

Please notify our office in writing if your organization changes its name.

Also, provide our office with a photocopy of the filed Articles of Incorporation and the Charter Number if your organization is incorporated, and we will consider the corporation for exemption from the state franchise tax.
